WHAT DOES ICONIQ CAPITAL, LLC AND AFFILIATES DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security Number
- Date of Birth
- Address
- Occupation and Employment Status
- Financial Goals
- Assets, Income and Account Balances
- Investment Experience and Risk Tolerance
- Information received from credit bureaus including credit history
- Information from your wills, trusts, and other estate planning documents
- Information about your holdings or transactions with us, our affiliates or others
- Mortgage rates & payments
- Wire transfer instructions

How?

All financial companies need to share Clients' personal information to run their everyday business. In the section below, we list reasons financial companies can share their Clients' personal information; the reasons ICONIQ Capital, LLC and its affiliates choose to share; and whether you can limit sharing.

Who is providing this notice?	ICONIQ Capital, LLC and its affiliates (as defined below; collectively, “ICONIQ” or “we”).
What we do	
How does ICONIQ protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We have policies and procedures designed to reasonably ensure the proper handling of customer information by employees and to require third parties to adhere to appropriate security and confidentiality standards.
How does ICONIQ collect my personal information?	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> ▪ Seek advice about your investments or make deposits or withdrawals from your account ▪ Give us your income information or contact information ▪ Open an account ▪ Fill out subscription documents for investment funds or vehicles ▪ Pay your bills using our bill pay services ▪ Enter into an advisory contract <p>We also collect your personal information from other companies.</p>
Why can't I limit all sharing?	<p>Federal Law gives you the right to limit only:</p> <ul style="list-style-type: none"> ▪ Sharing for affiliates’ everyday business purposes – information about your credit worthiness ▪ Affiliates from using your information to market to you ▪ Sharing for non-affiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing [See below for more on your rights under state law.]</p>

Affiliates	<p>Companies related by common ownership or control. Non Affiliates	<p>Companies not related by common ownership or control. Joint Marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <p><i>ICONIQ doesn’t jointly market.</i></p>

Other Important Information

California Residents: Except as permitted by law, we do not share nonpublic personal information we collect about California residents with non-affiliates. We restrict sharing with affiliates to comply with applicable California privacy laws.
